This easement shall be not less than 10 feet nor more than 15 feet in total width, measured with equal parts to the center of the water pipeline or waterworks facility. IE., 5 feet to the left of the water main and 5 feet to the right of the water main for a total of 10 feet in width.

The Member Agrees to grant the Association, its successors and assigns, the right to enter upon the above-described land, where the Association currently maintains, or intends to construct a water pipeline, meter assembly, or other appurtenance and remove vegetation by, any of, but not limited to the following means: mulching, chipping, cutting, grinding, grubbing, dozing, and other forms of vegetation, brush, and tree removal, and ongoing maintenance of said Right of Way.

accommodations to access the waterworks facilities.
